NARRATIVE FOR SERGEANT BRYAN C HAUGHEY

Ref: 08-18-OF

1. On Wednesday March 5, 2008 at approximately 1500 hrs <u>Johnson</u>, (<u>Brian</u>) reported his neighbor <u>Haney</u>, (<u>Alexander</u>) advised him he had a verbal altercation with a person sitting in a motor vehicle in front of his residence, <u>65 Stafford Rd</u>. (Stafford Rd is a public way in the town of Holland). He states <u>Haney</u> believes the person was watching both his and <u>Johnson's</u> residence, <u>61 Stafford Rd</u>. <u>Johnson</u> stated <u>Haney</u> reported the incident to the State Police and the man in the car identified himself as <u>FREI</u>, (<u>Peter</u>).

- 2. I contacted New Braintree Regional Dispatch (C-8) and they confirmed at 1410 hrs a call from the <u>Haney</u> residence was received reporting a suspicious man sitting in a vehicle in front of the residence. According to C-8 the call was transferred to the Massachusetts State Police (C-5) barracks. I contacted C-5 and was informed the responding Trooper was unable to locate any vehicle matching the description given, (2 door green Cadillac).
- 3. <u>Johnson</u> informed me he is aware <u>FREI</u> is friends with <u>La Mountain</u>, (James), who threatened to do bodily harm to his children as a result of a past incident involving the Town of Holland Highway Department, <u>Johnson's</u> employer (Ref: Holland Police Department incident number 07-38-AR). <u>Johnson</u> also states <u>FREI</u> has been posting blogs on the Worcester Telegram & Gazette website accusing him of illegally obtaining land while constructing his residence.
- 4. In a verbal and written statement <u>Haney</u> says he saw a green Cadillac parked in front of his residence with a man inside. He states he believes the man was watching either his residence or <u>Johnson's</u> residence and decided to approach after the vehicle had not moved for approximately 1/2 hour. He states he asked the man if he could get him something, prompting the man to say mind your business. He states he said it was his business because he has been watching his house and his neighbors house, prompting the man to say it's a public road I can do what I want. <u>Haney</u> states he informed the man he was going to call the police, prompting the man to say my name is <u>Peter Frei</u> then he drove away, smiling and waiving after a few moments.
- 5. <u>Haney</u> states he does not know <u>FREI</u> and initially became concerned because his wife and young children are usually home alone during the day while he is at work. According to th Registry of Motor Vehicles computer system (MA PC 58FN31), 1991 Cadillac Eldorado Coupe color green is actively registered to <u>FREI</u>. I will attempt to contact him in regards the altercation and his suspicious actions.
