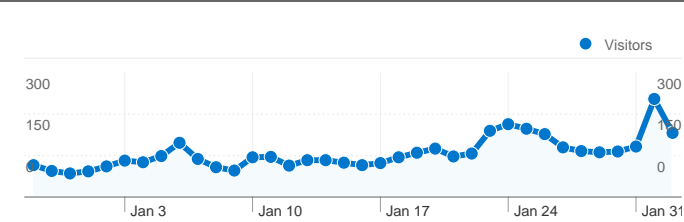

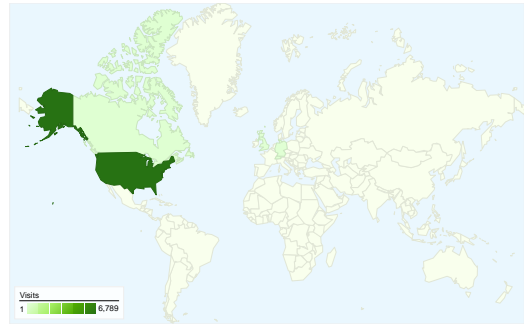

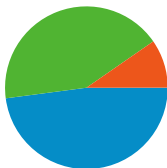

**Traffic Sources Overview**

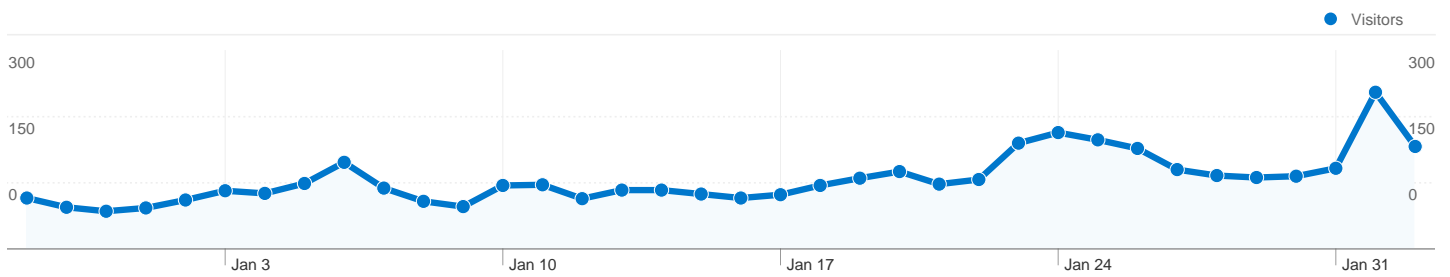

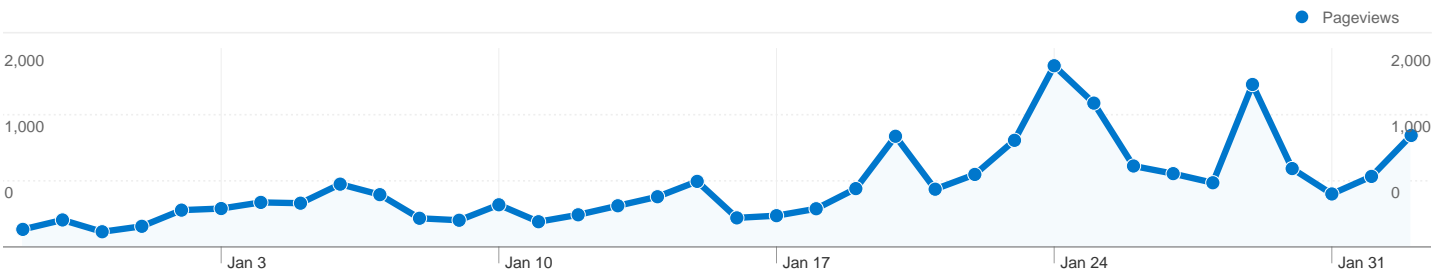

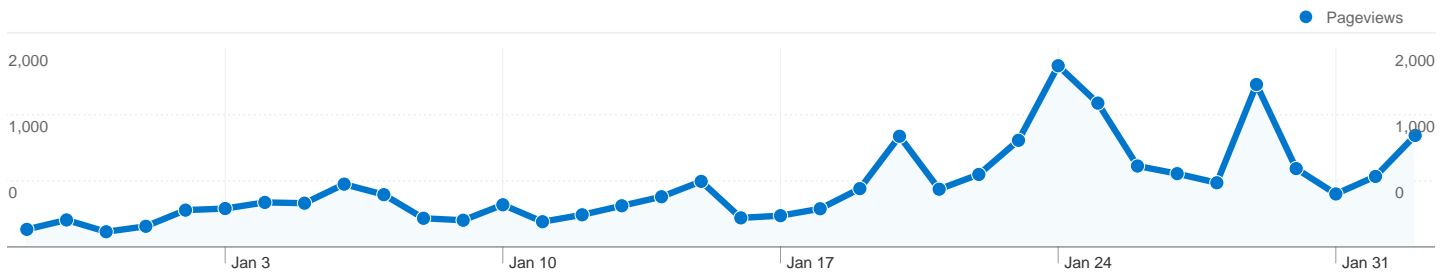
