

## PALMER DISTRICT COURT

### Request for a "HARASSMENT PREVENTION ORDER" pursuant G.L. Chapter 258E:

I, Peter K. Frei, living at 101 Maybrook Road, Holland MA, SS# 018786852, DOB 03-15-1951, phone: (413) 245 4660, respectfully request the order to be issued against:  
**Brian Johnson**, 61 Stafford Road, Holland MA 01521, DOB 12-23-1977, Highway Surveyor of the Town of Holland, and son of former selectman Earl Johnson, 10 Hisgen Road, Holland MA, 01521, DOB 06-16-1943.

I, Peter K. Frei, am a permanent resident of Holland since 1994, and a citizen of the United States. I was forced to sue Brian Johnson's father and other town officials in the past over land division issues and zoning issues in Superior Court; the most noticeable was a request for an order in mandamus to force the Planning Board of Holland to sign a so called "Approval Not Required" plan to divide a parcel of land.

The issue was decided in my favor after a grueling appeal to the Appeals Court of the Commonwealth.

Thereafter, I exposed the Johnson family, especially Earl Johnson and Brian Johnson, for illegally conveying a 12 plus acre land-locked parcel of land owned by the town to their family without paying for it.

Earl Johnson, father of Brian Johnson, was selectman for many years, a planning board member, and still is one of the tax assessors of the town of Holland.

His son, the accused Brian Johnson, ended up with one of the parcels illegally created by a corrupt Planning Board of which his father was a member after an engineering firm illegally drew and registered - at the Registry of Deeds - a plan creating a right of way to the land locked parcel out of thin air. The plan was drawn for the accused Brian Johnson despite the fact that he was not even the owner at the time.

I, Peter K. Frei went online with the "Holland Blog," on February 14, 2009. The Holland Blog is an interactive website to expose and report about ongoing corruption at the town hall of Holland. The Blog generated up to today 465'765 hits and had 120 visits per day on average in its

754 days of existence (245 visits on average per day during the last 60 days).

To shut me up, Brian Johnson repeatedly harassed, intimidated, threatened, assaulted me, kidnapped me, and made false statements to many different police officers. During the last incident, Brian Johnson accused me of having made a treat for his life. I can prove that Brian Johnson's latest claim and attempt to criminalize me is a lie. Brian Johnson also employed some of his friends and employees of the Highway Department to intimidate, threaten, assault, batter, and kidnap me.

The following is a list of documented incidents perpetrated by the accused Brian Johnson:

**May 30, 2008:**

Brian Johnson, elected Highway Surveyor, attacked and harassed me verbally inside the town clerk's office, calling me repeatedly "white trash," and "Scum Bag" for no reason. This attack occurred in front of a witness, Kristin LaPlante, Town Clerk, Highway Department Secretary, and also wife of Tom LaPlante who is an employee of the Highway Department.

**September 30, 2009:**

Harassment, assault, attempted break-in into my car, and kidnapping by Brian Johnson and Alexander Haney. Alexander Haney is a close friend, neighbor and former part-time employee of Brian Johnson's Highway Department. Brian Johnson and Alexander Haney were holding me against my will (20 minutes) by caging me in while I was inside my car in the middle of Stafford Road to prevent me from leaving. The two ganged up on me and lied to two police officers (trooper John A. Puccia, MSP, and Brian Haughey, acting Chief of the Holland Police Department) in an attempt to have me arrested for allegedly trespassing. Documented on the Holland Blog at:

**December 7, 2009:**

Brian Johnson, driving a dark blue Ford F350 pickup truck with his underage daughter in the passenger seat, crossed

the snow and slush covered center of Stafford Road aiming at me in an attempt to drive me off the road. This happened in a spot where he was driving around a long curve bending to his right side.

**January 18, 2011:**

Alexander Haney, close friend of accused Brian Johnson and part-time highway employee, was driving the heavy front loader without the needed Hoisting License issued by the Department of Public Safety.

I took pictures while he was operating the 21,000 lbs machine around the Holland Elementary School to report about it on the Holland Blog. Alexander Haney assaulted and battered me while I was taking pictures.

During a hearing in this court on February 28, 2011, Honorable Justice Patricia T. Poehler issued a Harassment Prevention Order against Alexander Haney, docket # 201143RO000022.

While I was writing my Voluntary Statement about the aforementioned incident (Exhibit 9) sitting in the little lobby of the Police Station in Holland, Brian Johnson came out of the office into the little lobby and stood right next to me and tried to read what I was writing.

I turned the clip board upside-down and raised my head up to look at Brian Johnson. He put his cell phone/camera 3-1/2" to my face pretending to take a picture while he said to me "FUCKING LOOSER." He then left the HPD.

I later noticed a dent in the driver door of my car, a Cadillac Eldorado Touring Coupe, 1991. The dent does not have any scratch marks that would be indicative of impact with another car.

I filed a Voluntary Statement with the Holland Police Department, see Exhibit 12.

**January 29, 2011:**

An I-reporter sent me a picture by MMS of a heavy machine plowing in front of Brian Johnson's father. I posted a piece on the Holland Blog with the title: "Do You Recognize the House Which is Plowed-out Here?"

**Brian Johnson made two harassing phone calls at 16:40hours and at 16:42hours.**

Johnson called me, "the dumbest person" he ever knew and also called me a "joke."

**January 30, 2011:**

Brian Johnson made two harassing phone calls at 7:31 hours and 7:33 hours. All calls had blocked IDs.

**February 19, 2011:**

The Holland Rod and Gun Club organized a fishing derby on Hamilton Reservoir in Holland MA for Saturday February 19. Around 06:25 hours, Brian Johnson and a group of about eight other individuals started drilling holes with power augers all around my house which is only about 1 to 5 feet away from the lake (ice) which surrounds my house on three sides. All day the group of men was revving their engines as they drove around the house and drinking beer all day. Brian Johnson and his friends were the only fishermen on the entire lake south of the case way, or at least as far as I could see.

I have never seen Brian Johnson fishing around my house since I bought the property in 1987.

At around 15:00 hours, I was going to get my mail and put my garbage out on the curb.

My girlfriend who was with me the entire time was concerned about my safety and suggested I should record audio while going to get my mail and suggested also she would videotape, just in case.

As I was ready to leave the house, she witnessed at least two men trespassing onto my property. On my way to the mail box (following my driveway instead of the shortest way I usually take), I intercepted the two men trespassing my property and asked them to go back. On my way back to my house, I walked the shortest way - as I always do during the winter - and intended to inform the accused Brian Johnson and his friends and employees that I would not tolerate anybody trespassing.

As I approached the group of men, Brian Johnson said something to me which I did not understand, I asked:

**"Are you talking to me, hu?"**

Brian Johnson said:

**"wasn't there somebody else in the house?"**

I answered:

**"hu?"**

Brian Johnson:

**"What do you want?"**

I said:

**"hu?"**

The assailant Al West said:

**"Get the fuck out of here!"**

Brian Johnson said:

**"Get out of here! Get the fuck out of here!"**

**"You know that that's my property..."**

The assailant, followed by others:

**"Get the fuck out of here!"**

I noticed that the assailant was in the process of taking off his winter jacket and I realized that Brian Johnson's gang was about to give me a good "gang-beating."

Brian Johnson:

**"GET THE FUCK OUT OF HERE, RIGHT NOW!! YOU BETTER GET THE FUCK OUT OF HERE!!"**

While Brian Johnson was still talking, the assailant Al West, kicked me in the back of my lower legs and I fell backwards on the ice.

As I was lying on the ice, Brian Johnson positioned himself in a way so he could kick me in my head with his heavy shoes with steel spikes. As he started taking a swing with his right foot, I started laughing and said:

**"That's great.. you know what.. because she is videotaping.. hahaha.."**

Everybody froze immediately, Brian Johnson:

**"huhuhu"**

I said again:

**"that's just great.."**

I got up and walked towards the house. Once in safety, I called 911.

According to the Police Incident Report # 11-31-OF, (Exhibit 11), the following six individuals were present: Brian Johnson, Al West, John J Folger, Anthony Fortuna, David B Cawley, and Thomas A LaPlante.

I'm in the possession of a picture showing Officer Jeffrey Forcier and Leonard R Bean talking to a group of eight men.

I'm only familiar with Brian Johnson and also know the face of the assailant I believe to have the name Al West. Al West is the father in law of Brian Johnson.

Sergeant Jeff Forcier from the HPD refused to give me an opportunity to point out the assailant. He's answer to my request to go out there and positively identify the assailant was, "I don't want to escalate the situation."

I posted a picture of the assailant on the Holland Blog and two readers identified the assailant as Al West.

Al West is also the father of the current owners of one of the illegally built homes off of Stafford Road, the property which is the subject of the Johnson LandGate scandal I exposed on the Holland Blog.

Jeff Forcier asked me to identify the assailant from a distance of about 250' which I refused to do as I did not feel comfortable as I could not see their faces.

Forcier's claim that I was unable to identify the assailant "because all the people on the ice had changed jackets with each other," is wrong. I stated to Forcier that the assailant was taking off his jacket to get ready for a fistfight.

As I did not engage him and instead tried to walk by him, West kicked me in the back of my legs.

According to Jeff Forcier Narrative, (Exhibit 13) Brian Johnson not only denied the incident and his involvement, he allegedly accused me of the crime, "threat to commit a crime, the crime of murder."

Fortunately, I have an audio recording (Exhibit 14) of the entire incident which proves otherwise and exposes Brian Johnson as A DANGEROUS VIOLENT INDIVIDUAL AND LIAR.

Narrative of the audio:

I'm getting ready,

At 0:30 minutes, Dana Manning witnessed trespassers;

at 1:32. I say, "I might catch-up to them,"

at 1:40, I leave the house and run up my driveway;

at 2:34, I intercept two men crossing from the lake to Maybrook Road trespassing over my property and I say, "Hey

guys, back, you are trespassing, back,"

at 2:44, trespasser says, "don't worry about that.."

at 3:19, I roll the trash bin to the curb;

at 3:56, I push the trash bin into the snow bank;

at 4:18, I close the lid to my mailbox;

at 4:30, I'm walking back the shortest way down towards the lake;

at 5:52, I'm taking the last step onto the lake;

at 5:53, Brian Johnson starts talking to me;  
at 5:55, I say, "hu?"  
at 6:00, I say, "what?"  
at 6:02, I say, "Are you talking to me, hu?"  
at 6:06, **Brian Johnson asks me, "wasn't there somebody else in the house?"**

Brian has the callousness to ask me, his victim, whether there are any witnesses before he attacks me with his gang...

At 6:08, I say, "hu?"

At 6:09, Brian Johnson says, "What do you want?"

at 6:10, I say, "hu?"

At 6:11, the assailant says, "Get the fuck out of here!, Brian Johnson says, "get out of here! Get the fuck out of here!"

At 6:12, I say, "you know that that's my property (where the two trespassers just walked on)..."

At 6:13, the assailant says, "get the fuck out of here!"

At 6:14 Brian Johnson says, "GET THE FUCK OUT OF HERE!"

At 6:15 Brian Johnson says, "RIGHT NOW!!"

I noticed that the assailant was in the process of taking of his winter jacket to get ready for a fist fight(?) and I realized that Brian Johnson's gang was about to give me a good "gang-beating."

At 6:17, Brian Johnson says in a threatening manner, "YOU BETTER GET THE FUCK OUT OF HERE!!"

At 6:18, while Brian Johnson was still talking, the assailant kicks me in the back of my lower legs and I fall backwards on the ice.

As I was laying on the ice, Brian Johnson positioned himself in a way so he could kick me in my head with his heavy shoes with steel spikes strapped to his shoes.

As Brian Johnson started taking a swing with his right foot;

at 6:22, I said, "oh that's great.. you know what.. because she is videotaping.. ha ha ha.."

Everybody froze immediately, and I started laughing as I realized that I just escaped relatively unharmed a vicious attack by Brian Johnson's gang which could have cost me my life.

At 6:26, Brian Johnson, "huhuhu;"

at 6:27, I said again, "that's just great.. that's what I needed.." and I get up.

At 6:29, Brian Johnson says, "get the fuck away from me, you are fucking harassing us!"

At 6:32, somebody says, Brian.. Brian, Brian.., while I'm asking the assailant for his name which I thought was Tom

LaPlante because of his facial hair and because he was about the same build. I still don't know 100% if the assailant's name, the assailant in the picture above, is Al West. The assailant's name was given by two readers of the Blog as Al West.

Al West is allegedly the father in law of Brian Johnson, and Brian Johnson's wife Kristen is therefore Al West's daughter. The Albert C West who lives at 166 Stafford Road, is allegedly the brother of Brian Johnson's wife and therefore the son of Al West.

At 6:34, I say astonished, "WAU... that's just great.. thanks.. you made my day.. you made my day!" I realized that I just escaped a violent attack – by a drunken out of control Brian and his violent gang – probably even death. I walk towards the house.

At 7:29, I open the door to my house;

at 7:32, I close the door to my house.

Once in safety, I called 911.

The assailant which I believe to be Al West, is living in Southbridge, and is pictures on Exhibit 18.

I made a Google map to show the location where the assault happened as it becomes clear that Brian Johnson and his gang choose the location deliberate. See Exhibit 19.

I, and other members of our community, fear for my life as the situation is escalating and spinning out of control. Brian Johnson is used to get his way but has been unsuccessful so far in his attempt to "shut my up." Brian Johnson will make other attempts to hurt me or to get rid of me.

I respectfully request that this Honorable Court issue a "HARASSMENT PREVENTION ORDER" pursuant G.L. Chapter 258E. I hereby certify that the facts contained herein and in Exhibits 1 - 19 are true and correct to the best of my knowledge. Any False statement(s) made are punishable under the penalties of perjury pursuant to G.L. Chapter 268, Section 1 & Section 1A.
