## **DECLARATION:**

I Peter Frei declare and state:

1. My name is Peter Frei and I am the defendant in this action. I make this declaration in support of Defendant's Request For Sanctions Against Plaintiff's Attorney, Tani Sapirstein. The facts set out below are known to me personally and if called on I could testify to those facts under oath.

Contrary to Frei's representation to this Court, the Supreme Judicial Court expressly rejected the requirement of a reasonable expectation of privacy as an element of a civil action claim under G.L. c.272, §99Q. "[W]e would render meaningless the Legislature's careful choice of words if we were to interpret 'secretly' as encompassing only those situations where an individual has a reasonable expectation of privacy." Id at 601, citations omitted.

- 3. Tani Sapirstein signed her opposition which included the statement under the previous paragraph.
- 4. Tani Sapirstein's statement is a falsehood.
- 5. Tani Sapirstein's statement refers to Supreme Judicial Court (SJC) opinion in the case *Comm. V. Hyde*, 434 Mass. 594 (2001).
- 6. In *Hyde*, The SJC is quoting the opinion *Commonwealth v. Jackson*, 370 Mass. 502 (1976).
- 7. Both opinion, *Hyde* and *Jackson* are criminal cases.
- 8. In *Jackson*, the word "civil" and the section, term, or word "c.272, §99Q," are not mentioned at all and also do not appear in any other shape or form in the entire *Jackson* opinion.
